

# OFFICIAL RULES

- 1. Sweepstakes Administration** This Sweepstakes is being administered and operated by iQ Credit Union.
- 2. Sweepstakes Period** The Cruiser Bike Giveaway period runs from 12:00 AM on April 3, 2017 until 11:59 PM on June 30, 2017. The winners will be selected no later than two (2) business days following the contest period and will be notified by telephone or email. If there is no response to the telephone call or email within 48 hours of notification, another winner will be drawn.
- 3. Eligibility** To be eligible for the Cruiser Bike Giveaway you must be a natural born person, lawful permanent resident of the United States, 18 years of age or older. Employees of iQ Credit Union, Board Members and their immediate family members are not eligible to participate. The iQ Credit Union Cruiser Bike Giveaway is available to new and existing iQ Credit Union members. All new membership accounts are subject to iQ Credit Union's normal approval process. A minimum opening balance of \$5 is required for a Savings Account.
- 4. How to Enter** Each iQ Credit Union member who receives a new iQ Credit Union Visa Credit Card during the Sweepstakes period is entered to win. The winning entry for each drawing will receive one of the custom iQ cruiser-style bicycles displayed in the iQ Credit Union branches.
- 5. Alternative Mail-in method of entry** If you desire to enter the contest other than receiving an iQ Credit Union Visa Credit Card, hand print your iQ Branch location, your name, address, day and evening phone numbers, email address, and date of birth on a 3" x 5" index card and mail it in an envelope with proper postage to "The Cruiser Bike Giveaway" c/o Marketing Department, PO Box 1739, Vancouver, WA 98668-1739. You will receive one (1) entry into the Sweepstakes. Limit: One (1) entry per envelope and a total of one envelope during the entire sweepstakes period. All mail-in entries must be handwritten and must be postmarked by June 15, 2017. All entries become the exclusive property of iQ Credit Union and will not be acknowledged or returned. Proof of sending or submission will not be deemed to be proof of receipt by iQ. iQ is not responsible for lost, late, incomplete, invalid, unintelligible, illegible, misdirected or postage-due entries, which will be disqualified.

The drawings for the winning entries will be held within two (2) business days of the end of the drawing period. The prize winners will be randomly selected from all eligible entries. iQ Credit Union reserves the right to disqualify any account if circumstances where iQ Credit Union reasonably believes that entries were not sent to iQ Credit Union in good faith. Odds of winning are dependent on the number of entries received.
- 7. General Conditions** iQ Credit Union will select the prize winners. The value of the Cruiser Bike Giveaway prize will be reported to the IRS.
