1. Sweepstakes Administration This Sweepstakes is being administered and operated by iQ Credit Union.

2. Sweepstakes Period The Cash Giveaway Sweepstakes period runs from 12:00 AM on April 3, 2017 until 11:59 PM on June 30, 2017. The winners will be selected no later than two (2) business days following the eligible drawing date(s) and will be notified by telephone or email. If there is no response to the telephone call or email within 48 hours of notification, another winner will be drawn.

3. Eligibility To be eligible for the Sweepstakes you must be a natural born person, lawful permanent resident of the United States, 18 years of age or older. Employees of iQ Credit Union, Board Members and their immediate family members are not eligible to participate. The iQ Credit Union Cash Giveaway Sweepstakes is available to new and existing iQ Credit Union members. All new membership accounts are subject to iQ Credit Union's normal approval process. A minimum opening balance of \$5 is required for a Savings Account.

4. Opt In To participate in the Sweepstakes, you must visit iQcu.com/cashgiveaway and opt in to the Sweepstakes. You only need to opt in once and all your qualified purchases between April 3, 2017 and June 30, 2017 will be counted.

5. How to Enter You must "Opt In" to be eligible to win. Then, each time an iQ Credit Union member makes a minimum \$25 purchase using their iQ Credit Union Visa Credit Card, they will be entered into the drawing. One entry per purchase. Drawings will be held no later than two (2) business days following the eligible drawing periods:

purchases between April 3 - April 30, 2017 will be eligible for drawing #1
purchases between May 1 - May 31, 2017 will be eligible for drawing #2
purchases between June 1 - June 30, 2017 will be eligible for drawing #3

The winning entry for each drawing will receive \$500 deposited into their checking or savings account.

Alternative Mail-in method of entry If you desire to enter the Sweepstakes other than making purchases with your iQ Credit Union Visa Credit Card, hand print your name, address, day and evening phone numbers, email address, and date of birth on a 3" x 5" index card and mail it in an envelope with proper postage to "The Cash Giveaway Sweepstakes" c/o Marketing Department, PO Box 1739, Vancouver, WA 98668-1739. You will receive one (1) entry into the sweepstakes. Limit: One (1) entry per envelope and a total of one envelope during the entire sweepstakes period. The prize winners will be randomly selected from all eligible entries. iQ Credit Union reserves the right to disqualify any account if circumstances where iQ Credit Union reasonably believes that entries were not sent to iQ Credit Union in good faith. Odds of winning are dependent on the number of entries received.

7. General Conditions iQ Credit Union will select the prize winners. The value of the Cash Giveaway Sweepstakes prize will be reported to the IRS. The recipient is responsible for any federal, state, or local taxes on this bonus item. Void where restricted or prohibited. Prizes are non-transferable, non-assignable and non-exchangeable.
